Setting Goals in Salt Lake City

While the skies above Salt Lake City were hazy Aug. 7-9 due to wildfires to the west, the objective at the 94th annual Union Pacific Employee Clubs Convention was clear - continue to grow the ranks.

Gathered at the Sheraton Salt Lake City hotel, delegates representing nearly 30 clubs discussed the organization's accomplishments in the prior year and plans for the future. Among them were delegates from two recently reactivated clubs: Club 82 of Dalhart, Texas, and Club 85 of Avondale, Louisiana. Club 87 also was activated in Phoenix.

Since last year's convention in Sacramento, California, members have volunteered a combined 95,914 hours of their time while driving 200,208 miles - that's more than eight trips around the earth's equator. Total donations amounted to $\$ 2,277,952$.

During the Aug. 8 awards luncheon, Vice

President-Engineering Eric Gehringer highlighted many of his department's cutting-edge equipment, and its efforts in reopening a Cascade Subdivision tunnel near Oakridge, Oregon, following its May collapse. The next evening at the awards banquet, Senior Vice PresidentTransportation Shane Keller regaled the audience with a story of his early days at North Little Rock, Arkansas' Jenks Locomotive Shop, where he worked with Richard Baldwin, former Executive Committee chairman and Friend to Friend Network treasurer. He then provided an overview of the state of the railroad before joining Executive Committee Chairman Bob Moore in presenting awards to honored clubs.

On the final day of the convention, delegates elected Randol Royce of Club 66, San Antonio, to succeed Moore as Executive Committee chairman. Serving as vice chairman will be Kenny Willis of Portola, California's Club 38.
