## F2F Helps 1,000 Texans

As of March 4, Friend to Friend Network has helped 1,000 families throughout Texas. Russ Lowe, director-regional operations, has served as a Friend to Friend ambassador in the state since the beginning of the Friend to Friend Network in 2004.

“There are a lot of charitable organizations out there — United Way, your church — but this is one for which every penny goes to help Union Pacific families,” he said. “I have seen how it helps. It is 100 percent for UP employees and retirees.”

Lowe himself has helped close to 200 families reap the benefits of Friend to Friend. These are a few of their stories.

Brian Reddick, a Fort Worth Diesel Shop locomotive foreman, joined the railroad more than 20 years ago, working first as a fireman & oiler before becoming a machinist apprentice. He has worked as locomotive foreman since 1997.

In 2011, Reddick’s family was met with trying circumstances.

He needed to take a leave of absence and would have to go nearly two weeks without a paycheck.

“It takes at least 10 days to get funds from railroad retirement insurance, and we were struggling to begin with,” Reddick said. “During that time, we were dealing with a situation and had at least 10 days with no pay. Fortunately, I knew about Friend to Friend.”

Reddick was approached by Russ Lowe, director-regional operations and Friend to Friend ambassador.

“It was less than five days from when I talked to him and when we got our check in the mail,” Reddick said. “The things we were going through, I imagine that if we had a video camera on my face and my wife’s face, it would have said it all. It was like a gift from God. That just made the difference in our lives.”

Reddick and his wife, Jeannine, had two children ages 6 and 11 at the time. The money from Friend to Friend helped them buy food and pay some bills, Reddick said.

Since then, the Reddicks have welcomed twins to their family,

## Friend to Friend Wins Big in Vegas

A spontaneous drawing occurred during a recent Las Vegas training meeting with Signal employees, which caused a stir among Friend to Friend Network devotees.

Employees donated toward the drawing by purchasing items such as baseball caps, T-shirts and travel mugs during a two-week span. Most employee donations exceeded the value of the items.

Employees understand the network’s importance, and several have benefited from it. The situation happens the same way every time — just when an employee least expects it, a check shows up in the mail and makes his or her day, or month.

“Employees will give me a call when this happens, and tell me it couldn’t have come at a better time,” said Bobby Caughron, signal safety foreman.

Hurricanes, tornadoes, fires and medical challenges are some of the common reasons behind sudden employee financial need.

“The program’s incredible,” Caughron said. “Every time an employee has an unexpected financial need, a team looks over the reasons and decides if the individual needs the money.”

Many employees use automatic deductions as a way to give to the Friend to Friend Network. Caughron is pleased with the amount of support. By the end of the annual training, employees raised about \$2,550.

“I can’t brag enough about the people here,” he said. “Some of them stopped by two to three times to buy more stuff. They understand the need.”

This tournament has become our most impactful fundraiser, and a fun way to ring in the spring season and catch up with old friends. We hope this year's event will enable us to help at least as many families in 2013 as it has in years past.

## Jillian's Friends

Friend to Friend joined UP Employee Club 86 in December to help a California girl receive needed medical care and new hearing aids.

Jillian Kulinski, 12, daughter of Roseville Locomotive Electrician Bob Kulinski, was diagnosed with brain tumors early in her life.

She has fought through infections and partial paralysis, chemotherapy, hearing loss and re-learning to crawl and walk — twice.

In 2012, the Friend to Friend Network, led by local ambassador Cathy Gregg, helped Jillian and her mother, Julie, fly to Houston to see a specialist about Jillian's brain tumor.

Friend to Friend also joined with UPEC 86 and Bob Kulinski's co-workers at Roseville Locomotive to help Jillian obtain new hearing aids. They submitted Jillian's story to the Sacramento Bee's Book of Dreams, an annual storytelling series that garners assistance for people in need.

New hearing aids were not covered by the family's medical insurance, and Jillian had been wearing the same pair for seven years. In order to hear her teachers in school, she wore a special device that covered her hair, which she did not like.

"She was chosen among many other submissions to have the story placed in the book, requesting assistance," Gregg said. "She received the hearing aids at no charge."

Danny Brattin, Fort Worth Diesel Shop electrician, thanks Friend to Friend Network and its contributors for assistance provided to his family.

Brattin met with a medical circumstance beyond his control in September 2011; his knee was injured and he ended up being out of work for nearly seven months.

Because Brattin is a retired Marine with 20 years of military service, he did not receive short-term disability. Friend to Friend was able

to help him make ends meet during the period he was unable to work.

Brattin had a family to support, including his youngest son still at home; his wife, Fernanda; and his then-3-year-old granddaughter, Kayla.

"It's a wonderful organization," Brattin said. "You never know when some kind of disaster is going to strike. Things can change without a moment's notice."

Brattin has helped the Friend to Friend Network by contributing from his paychecks since he joined the railroad in 2006. Little did he know at the time that Friend to Friend Network would one day help him, too.

"It's nice to know it's there," Brattin said.

A Fort Worth Diesel Shop mechanical service operator received a little help from the Friend to Friend Network this past year.

John Reeves was unable to work for medical reasons. He was able to draw short-term disability, but needed help during the lag before disability payments start. At the time, he supported his wife, Jamie, and a teenage daughter.

"I think Friend to Friend is a good deal," he said. "It helps people when they really need it."

### ***Donate a Raffle Prize!***

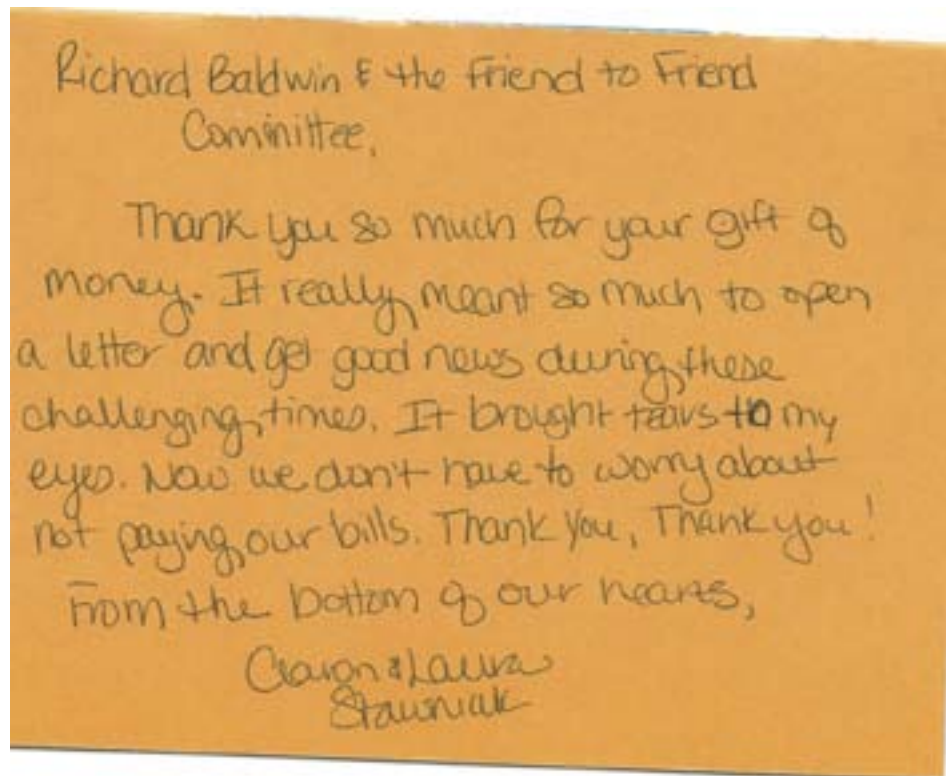

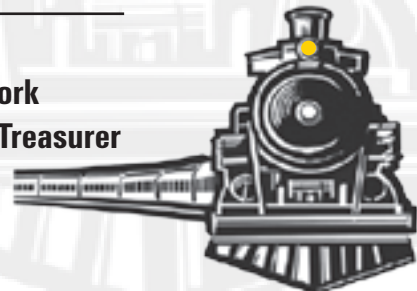
