If you need images other than the ones shown on our Web page, please contact the Museum at 402-501-3841 for additional assistance. The Union Pacific collection includes more than 500,000 images.

If you require images that are not shown on our website, the research fee is \$75 per hour, billable in half hour increments. A deposit of \$50 is required prior to beginning photo research. Photo searches usually produce 5 to 10 images per half hour of research. You will be billed for research WHETHER OR NOT we find a photo that meets your requirements; however, we will inform you in advance whether a search is likely to be productive.
