 - Target Payout of 40 to 45%
- Share Repurchases
 - Three year Target of \$20 Billion by 2020
 - Repurchased \$13.4 Billion through Third Quarter 2019

2019 Outlook

- Fourth Quarter Volumes Down at Least 10%, with Revenue Down Slightly Less
- Pricing Well in Excess of Inflation Dollars
- Capital Spending of ~\$3.1 Billion
- Significant Productivity Savings from G55 and 0, Including Unified Plan 2020
 - At Least \$500 Million in 2019
 - Fourth Quarter Force Levels Down At Least 15%
- Reiterate Operating Ratio Guidance
 - Sub-61% in 2019
 - Below 60% in 2020
