On March 16, 2021, Lance M. Fritz, Chairman, President, and Chief Executive Officer of Union Pacific Corporation (the Company), addressed the 2021 J.P. Morgan Industrials Conference. Mr. Fritz reaffirmed full year fiscal 2021 guidance. Mr. Fritz also provided that the impact of winter weather and rising diesel fuel prices will prevent the Company from improving its year-over-year operating ratio in the first quarter.
