On December 1, 2021 Jennifer L. Hamann, Executive Vice President and Chief Financial Officer of Union Pacific Corporation (the Company), addressed the 2021 Stephens Annual Investor Conference. Ms. Hamann reaffirmed the Company's expectation that 2021 will be a record financial performance, but modified the Company's full year fiscal 2021 guidance lowering volume growth to approximately 4%, productivity to approximately \$250 million and operating ratio improvement to around 150 basis points.
